Jacobs added to the report on the Community Resource Development Fund Unmet
Needs announcement made during the meeting for stakeholder input. Jesse said

available for CAC participation outreach at any vendor sites.

- VI. <u>HCBS Final Rule- Principles, Guidelines and Implementation Activities "HCBS Final Rule Requirements, What an HCBS compliant setting should exhibit?"</u>
  - Christina Ontiveros with support by Frances Jacobs shared the importance of having everyone involved in the HCBS Rule, to fill out the handout for training topics in the near future to ensure being aware of the compliances with the rule by 2020. Informational sessions will be developed and an agenda item (s) will be given to Directors/ Managers of vendor services/programs to bring back to staff meetings to discuss monthly and an assigned note taker will be needed to compile responses to discuss items and questions that will be helpful in sharing to ensure compliance. Each vendor will be responsible for sending Christina Ontiveros their notes monthly prior to the following month VAC meeting as requested for each assignment, contiveros@elarc.org
  - Similar conversations about topics each month will be discussed at each VAC meeting moving forward, as there will be a different topic each month for vendors to discuss with staff at their company and return notes to Cristina.
  - For March, on ELARC website, go under Notices/ Publications HCBS Program
     Evaluator for email address following conversation with your staff to submit your
     notes.
  - CAPC was recognized for submitting the January and February staff discussion notes
  - For the past three months topic items, the notes from each vendor are due by the April VAC meeting.
  - Frances added that on the whole collaborative assignments are important as we "need to help each other" that's the bottom line, "you and staff need to be on the same page as well as with Service Coordinators and vendors as a whole. We cannot risk that in 2020 we are behind. We will lose Federal money if we don't ask for funding that may be available to make the necessary changes. Evaluations from Laura Brackin's presentation are the basis for all HCBS activities ELARC is employing to help staff and vendors come into compliance. So, we need all the feedback we can get to help us become compliant as we stay connected through meetings/trainings like today." Christina informed the group that working collaboratively is important, like the Lanterman Act says: "the people we serve must live like their non-disabled peers," whether or not certain service categories are identified or not for HCBS compliance.

# VII. <u>Training: "Five Suggested Training Themes" - Group Discussion (Approximately given 15 minutes to work together to find topics for each title)</u>

- Five giant post its with the topic headings: Labor Laws, Health Issues, Emergency Response, Med/ System Safety, Osha Law Requirements, Staff Requirements for Services and Other
- Each table was directed to discuss each post it heading and write possible
   Training TOPICS/ Questions to post on each giant post it.
- One person stood by giant poster and read each one submitted by the VAC participants, and many really good topics were included as topics for each title.

  - While conducting outreach for CAC participation there will be initial and follow
    up contact with consumers to determine their satisfaction with job developer
    and coaching services of the vendor. Selected vendors will receive letters from
    ELARC to identify 1 to 2 consumers for Jessie to meet with in upcoming months.
- E. AB 918 passed in 2015 as is in the Welfare & Institutions Code Section 4436.5 about seclusion and restraint was mentioned by Frances
  - Chemical and Physical restraints (ie, a pill given to a consumer to calm down is a chemical restraint) must be reported by vendors to the RC in special incident reports as applicable, and this is not new, it has been an existing requirement. Vendors MUST report to RC each death or serious injury of a person occurring during or related to the use of seclusion, physical restraint or chemical restraint, and it will be used for data that DDS is required to publish on their website. This requirement applies specifically to residential services, supported living services, long-term health care facilities and acute psychiatric hospitals.
