Report from VAC Work Groups

Ethics

Emergency Operations Planning

Liz Harrell and ELARC staff will facilitate a tabletop exercise for a disaster event with approximately 40 vendors in the specified event area on November 7, 2018 in Whittier. Representatives from the Department of Developmental Services, Los Angeles County AFN Coordinator for Office of Emergency Management and San Gabriel Pomona Regional Center are expected to be present to observe. Liz Harrell will provide a report at the November 15th VAC Meeting.

ELARC Consumer Advisory Committee (CAC) Update

The last CAC meeting was held on 09/18 regarding Self-determination. Jesse reminded everyone that the next meeting is on 11/13. It will be on Emotional Health and Wellness providing fun and practical ways to cope with anger and stress. Everyone is welcomed. Jesse also announced the Annual State Capitol Tree Lighting Ceremony and that over the next month ELARC will be accepting ornaments made by consumers. These crafted ornaments will be sent to the State Capitol in time for the Tree Lighting Ceremony.

Training

Networking

Ron is still working out the logistics for the fair, regarding take down and set up fees, right now he said it may cost about \$2500. Aiming for the last week of April. Ron announced that Felipe might be partnering with a High School to host a vendor fair for students graduating and going out into the work community. If he is able to partner with the high school the fair would be held sometime in the fall. Next meeting will be held on 10/25 after the VAC meeting.

Last meeting was held on 08/28. George D. Employment Specialist talked about CIE and additional support options that are available to consumers and families. There was a presentation about the ELARC Reduced Caseload Disparity Project. In January 2019, there will be a training topic at the VAC regarding reduction in case load for Service Coordinators participating in the pilot project to address the disparity issues with some of the population ELARC's service area is currently facing.

TRAINING: "System Update", Gloria Wong ELARC Executive Director

Gloria Wong presented highlights on the: January 2019 preliminary budget and impact for the community services system; So Cal Regional Centers meeting with a Coalition of 17 Service Providers on 9/13/18 – (1) pursuing a unified voice regarding financial issues for our system, (2) strategic action plan to address legislators is in development for 2019-20 Budget, particularly a message for 8% across the board increase (3) Timing before Rate Study Release in March 2019, (4) Frances will work with ELARC vendors to expand in addition to the 17 present at the meeting for a unified voice; (5) So Cal Director's Group is also developing a matrix to collect information on individuals impacted and each regional center wants their vendors to be a part of that effort; Association of Regional Center Agencies (ARCA) had meetings with governor candidates Cox and Newsome - (1) ARCA will be releasing a new shite paper titled, "Building A System for Tomorrow"; there is a 6 billion dollar budget for 21 regional centers half of which is from federal funding and if we lose it the money will have to be backfilled from the general fund; Grass Roots Day I n March/April 2019; May Revise for the proposed budget; no word yet on the 25 million for minimum wage increases in local jurisdictions; Self Determination Update - (1) DDS selected 2500 consumers to participate, ELARC has 110 (2) 9,139 individuals registered as a show of interest (3) Mandatory Orientation Is in development at the state level; POS Disparity – (1) ELARC Report was sent to DDS, (2) local public meetings have been conducted, (3) Online summary reports are available on line at DDS website, (4) ELARC has 3 primary groups (White, Hispanic and Asian) dealing with the disparity issue, (5) ELARC now has a third project pending to mitigate differences. ELARC's specialized unit with lower caseloads as a pilot has been very successful. Gloria ended her presentation reminding everyone that November 6th is Election Day.

Upcoming Events/Announcements:

Yvette Baptiste, Director – Family Resource Center (FRC) offered to do a training for the VAC on how to collaborate and work with families which would be for one-half hour. She shared that the FRC had received grant funding from the Los Angeles County Department of Mental Health – Early Intervention to provide opportunities for individuals with developmental disabilities to learn about Health & Wellness. Loneliness and frustration is a real issue bringing risks. Their idea is to have a half day event in Whittier for the community. FRC is hoping to host this event "The Whittier Move and Groove" at the Lee Owens Park. They are looking for a co-sponsor with an address in Whittier – would any vendors be interested? The City of Whittier is requesting that there must be a Whittier address used in order to utilize the park facilities. The proposed event date is the end of October 2018.
