Consumer Advocate Report – Jesse Padilla

VAC

I attended the VAC and a few of the main topics were minimum wage, the HCBS finalrule on how service providers (especially for Residential Services) will need to more person centered. This means the consumer will be able to make their own choices without a third party choosing for them. There are 3 key points for this new HCBS final rule:

- Choices
- Rights
- Opportunity

Employment Committee

I presented at our Employment Committee and I showed the "Bottom Dollars" video. After the last CAC meeting I spoke with the George De La Loza, our lead employment specialist, and he asked me to present the documentary and explain why it's such a great resource for consumers and their families.

ARCA CAC

The ARCA CAC had a conference call where we chose some of the priorities for 2019. So far they are: Affordable Housing, Emergency Management/Preparation, Employment, and Legislative Action. Our next meeting is in October and the main topic will be abuse and awareness.

Access Services

Recently I attended the Access meeting and there were concerns about the eligibility process and how many considered the eligibility form not consumer friendly. Also: Metro did a study on bus patterns by looking at the number of frequent riders, occasional riders, and non-riders in order to improve the transit system as a whole.

Directors Report - Gloria Wong

- ELARC will be taking an aggressive campaign for the budget. New governor will not have much to do with this new budget. Our budget is currently dealing with current administration
- Nestor asked what are we supposed to ask our legislators? Gloria said to wait for the talking points.
- Anthony asked why are there funds being put aside? Gloria explained that the governor always puts money aside for "a rainy day." He is being cautious, but there is enough money in California for regional centers and that is why we must be aggressive.
- Virgilio asked, what can we do as consumers to move the budget the way it's supposed to go. Gloria answered that hopefully everyone present is registered to vote. Make your voice heard. Visit your local legislators. Liz suggested that Roxy come out to the CAC to provide a workshop. She also suggested that Carmen or the SC's on the specialized caseloads to come out and share the project and explain.
