Consumer Advocate Report – Jesse Padilla

Did you know that LA County is changing their voting system?

LA County's current voting experience is outdated and in critical need of new changes. Voters should be able to vote when, where and how they want. The new voting system under Voting Solutions for All People or VSAP is an important step to accomplishing these goals.

Here are some of the changes with the new voting system you will experience at March 2020 primary election;

- No more pre-printed paper roster, instead an electronic roster will be used to access data in real time at all voting centers. This will also make same day voter registration easier
- No more pare ballots, instead the system will allow voters to vote digitally
- In person voting available for 11 days instead of one- on election day
- Any voter can vote at any voting center on LA County instead of at their assigned precinct

These are some of the main highlights of the new voting experience all voters will go through at the next election. We have help all time, so you have to be very honest with your support staff and let them know when they have to stay out of your life and when they could help.
