## **ACADEMIC PROGRAMS INFORMATION**

ELARC supports efforts of universities and institutions of higher learning to include curriculum and experiences for students that introduce them to the field of developmental disabilities. To our best ability, within our staff capacity, ELARC will attempt to provide students in the community with the opportunity to learn about this important field through experiences with our agency.

#### University Internships

- o ELARC can serve as a site for university internships.
  - University interns are defined as college students currently enrolled in a field of study that
    requires the student be placed in a social service agency for a determined amount of time in
    exchange for college credit
  - Acceptance of interns is dependent upon staff supervisory availability
- o ELARC does not provide stipends for internships
- A pre-screening meeting is required
- o If accepted for internship, a background check and drug screen are required

  - All inquires should be made in writing and should include:
    - Name and contact information (email address and phone number)
    - University and field of study
    - Intended start and end date of internship
    - Intended hours per week (proposed schedule)

- o ELARC is a case management agency, not a site based direct services center. ELARC does not conduct tours of offices. Any potential interview with staff would most likely be by phone.

# Academic Studies (Theses, Dissertations, Studies)

- A written inquiry regarding working with ELARC on an academic study shall be directed to <u>info@elarc.org</u> The inquiry must be sent a minimum of one month prior to implementation of the study activities.
- If study includes any interaction with individuals and/or families served by ELARC, copy of the student's IRB approval must be submitted with the inquiry.
