VI. Report on Board of Directors Meeting, June 9th, 2020

Chair Bryan Chacon attended for the group. Important highlights include:

- A. Reviewed the DDS Directives and May Revise.
- B. Fiscal Year 1920 community placement plan was proposed to the Board of Directors. It is an RFP for a housing development organization project to acquire and renovate single family homes owned by an HDO for leasing to service providers as licensed residential facilities. These would be advance behavior support homes. Brilliant Corners was awarded the contract.
- C. Self Determination active participates at ELARC is 114. 100 completed self-determination orientation, 27 individual budgets were certified, 23 completed spending plans, 24 completed the IPP, and 12 person centered plan reimbursements were requested.

VII. HCBS Forum: HCBS Transition Plans/Heightened Scrutiny - Maribel Garcia

- A. Self-Assessment survey is due by August 31st 2020.
- B. Heightened Scrutiny is a term used in the Final Rule to describe a process for identifying and correcting issues or problems found during the assessment process.
- C. Based on responses from the self-assessment, it can trigger an on sight assessment and the Heightened Scrutiny Process.
- D. Characteristics of a setting that isolates HCBS beneficiaries from their broader community include:
 - i. Due to the design or model of service provision in the setting, individuals have limited, if any, opportunities for interaction in and with the broader community, including individuals not receiving Medicaid-funded HCBS
 - ii. The setting restricts beneficiary choice to receive services or to engage in activities outside of setting
 - iii. The setting is physically located separate and apart from the broader community and does not facilitate beneficiary opportunity to access the broader community and participate in community services, consistent with a beneficiary's person-centered service plan.
- E. The group went through the 4+1 Questions.
