 - Liz explained the process of funding

- We are putting out a lot on materials. Training really needs to be on a 1:1 basis. The amount
 of \$55,000 for materials, but \$80,000 for Nes Dan is a lot. It's almost like those have to be
 switched.
- Can we remove the Vietnamese and Korean translation for another time? And then adding the difference to Nes Dan?
- O What will Nes Dan actually do?
 - Does DVU have a mentoring program? DVU may be overwhelmed with reaching so many folks. If individuals don't know about SD, can she tailor her program for these individuals?
 - Proposals appeal about this proposal is that it puts a focus on one to one with family.
- o For the \$500 per workshop, will we reach enough people with one workshop?
- Developing videos adds value to the different types of modalities.
- O What happens if these projects don't work out, or they don't pull through?
 - Liz answered that they don't get paid. We have a contract and if that contract is not seen through they don't get the funds.
- o A parent stated, "If I were a voting member, I would want to know more about Nes Dan.
- o There needs to be a meeting with Nes Dan
 - Members did not feel comfortable voting for the Nes Dan proposal without further information/details
 - They wanted to know how long they have in order to make a decision.
 - A meeting will be set up with Nes Dan, Carola Maranon, Chris Arroyo, Alex Scarlis,
 Virgilio Orlina and five members of the implementation team.
- The motion to vote for the 20/21 proposals was tabled for the next meeting on June 15th.
