Alternative Services Reporting Update: First Report Due 11/25/2020

As follow up to the Department of Developmental Services' (DDS) August 31, 2020 Directive regarding Alternative Services during the COVID-19 State of Emergency, DDS has released correspondence which provides additional guidance on the provider reporting requirements noted in the Directive. Reporting on September and October

By November 25, 2020, providers must submit a report for each vendorization delivering Alternative Services for the initial period of September 1, 2020 through October 31, 2020, using SurveyMonkey. The survey may be accessed at:

Reporting on November
