Service Provider Updates

State of Emergency Absence Billing

The Department of Developmental Services (DDS) announced in two different state webinars/conference calls last week that it is targeting June 30th for the end of State of Emergency (SOE) absence billing for non-residential settings that have been in place since March 12th, when the Governor's state of emergency was declared. However, no official guidance or directive from DDS has been released as of this date. DDS did state that it would be releasing guidance on the details regarding how it will end the SOE absence billings in the near future without giving a specific date. ELARC recognizes that this issue has major impact for many of our providers and we will keep our community updated as we receive more information from DDS on SOE absence billing.

DDS Develops Draft of COVID-19 Re-Entry Plan

DDS has begun to develop a COVID 19 Re-Entry Plan that will include guidance and procedures for California's developmental services to safely operate and for consumers and families to make informed decisions about how and when to re-enter services during the COVID-19 pandemic. The draft plan outlines phases of re entry for all service types and is intended to align with the California "Resilience Roadmap." The plan is a draft at this time. ELARC will keep our community posted as on the release and implementation of this plan as we obtain information from DDS.
