Provider Relief Fund: Medicaid and CHIP Provider Distribution: July 20, 2020 Deadline to Apply

On June 9, 2020, the U.S. Department of Health and Human Services (HHS) announced the distribution of approximately \$15 billion from the Provider Relief Fund to eligible providers that participate in state Medicaid and Children's Health Insurance Program (CHIP) and have not received a payment from the Provider Relief Fund General Distribution. Please note with the recent enrollment of regional centers as Medi-Cal providers, regional centers may receive this additional funding. Last month, the Department of Developmental Services (DDS) provided comprehensive payment data for regional centers and providers in response to a request from the Centers for Medicare & Medicaid Services (CMS). The data states submitted to CMS will be used to validate this next round of provider relief funding.

Providers may submit their revenue information to the federal enhanced Provider Relief Fund Portal to be eligible for payment from this Fund. **Please note, applications are due July 20, 2020**. This funding will provide relief to Medicaid providers experiencing lost revenues or increased expenses due to COVID-19. It is uncertain how much funding will be available or how funding will be allocated. However, DDS wants regional centers and providers to be aware of the funding opportunity. DDS recognizes there are many unknown details and will share clarification as they receives them and ELARC will post upon receipt from DDS.
