Service Provider Updates

September 30 Deadline in Order to Ensure Timely Payment for Alternative Services Provided in September!

The Department of Developmental Services issued a directive on August 31stthat outline policies and procedures for utilizing alternative nonresidential services during the COVID-19 State of Emergency. This model has now gone into effect September 1, 2020. To allow a service provider to bill for Alternative Services effective September 1, 2020, DDS requires that service providers submit to Eastern Los Angeles Regional Center (ELARC) the DDS Certification of Alternative Nonresidential Services prior to billing for September services. This replaces all previous certifications requested by ELARC. Read the full correspondence with important deadlines here. Additionally, ELARC is requiring providers complete the Alternative Services Engagement Log.

Alternative Services are intended to meet the needs of individuals that have emerged during this ongoing public health crisis, <u>sustain services</u>, and continue receipt of federal funding. <u>Any non residential provider</u> may provide alternative services during this time but you must submit required documentation. **In order to bill for the services provided in September, those documents must be sent to ELARC by September 30, 2020.** Read correspondence in link in above paragraph for details. Contact your Community Services Liaison with questions. If you don't know who your liaison is just send an email to <u>esalazar@elarc.org</u> to find out. Time is running out to insure timely payment for services!

The engagement log is intended to help providers organize the information required in the directive into one easy reference document * Reference link to correspondence in first paragraph of this newsletter for certification and engagement log
- * ELARC has set up a calculator on our ebilling site to help you calculate alternative services billing for September. You are not required to use this calculator, it is intended only to provide assistance in your calculations.
