

## Self Determination Program Local Volunteer Advisory Committee ANNOUNCEMENT March 25, 2022 Request for Proposals Fiscal Year 2021/2022

Subject to funding approval by the Department of Developmental Services (DDS,) the Eastern Los Angeles Regional Center (ELARC) Self Determination Program (SDP) Local Volunteer Advisory Committee (LVAC) is seeking proposals for projects to support the implementation of the Self Determination Program in the ELARC community. DDS has awarded \$89,760 to the ELARC SDP LVAC for funding such projects in fiscal year 2021/2022. Interested parties are invited to submit a proposal.

## PROPOSAL CONTENT

At a minimum, proposals should include, but are not limited to, the following information:

     Applicants must identify what priority area(s) are addressed in the proposed project.
  - Identified Need in ELARC Community: Applicants should demonstrate understanding and knowledge of the unique nature of the ELARC community. Applicants should identify how the proposal specifically addresses strengths and needs of the ELARC community.
