# **ELARC Self Determination Local Advisory Committee December 1, 2015 Meeting Notes**

#### **Welcome and Introductions**

The meeting was called to order at 6:05 pm by Virgilio Orlina, Chair. A quorum was present to conduct business. Gloria Wong greeted the attendees and the members introduced themselves. Virgilio introduced Liz to present on the History and Principles of Self Determination.

#### **Updates**

- Statewide Self Determination Project Update
  - O Gloria shared that the Department of Developmental Services (DDS) Stakeholder Committee is guiding the process. DDS has reported that the application for federal funding was resubmitted at the end of September. The waiver is now currently within the 90 day review period by the federal Centers for Medicaid/Medicare Services (CMS.) CMS will either approve, deny, or return for clarification during that time. It is likely that the process will take longer than 90 days. There is another DDS Stakeholder Committee meeting will be held next week and more information should be made available as to the status of the waiver.
  - Correspondence from the State Council regarding pulling together the first meeting of the Statewide Advisory Committee was distributed. Per law, this Committee must be developed to guide process on

- the state level. Virgilio will serve as the ELARC Advisory Committee's representative. A date for the meeting has not been set.
- o Liz Harrell briefed the committee on the work of the Statewide Training Workgroup, a subgroup of the Stakeholder Committee. There are 15 training modules still in development now; some are sub topics of larger topics. The target date for all to be drafted in December 29.

### • Outreach and Information Planning

- Liz shared that ELARC has signed collaborative agreements regarding information and training activities
  with Fiesta Educativa, the Chinese Parents Association for the Disabled and the Greater Long
  Beach/San Gabriel Valley Chapter of the Autism Society. ELARC hopes to also enter into a collaborative
  agreement with the Autistic Self Advocacy Network as well. Dates are being calendared for information
  sessions with these groups for 2016 in coming weeks.
- Tracking attendance and effectiveness of information sessions: A list of all Self Determination Information sessions conducted thus far was distributed. The list includes the number signed in as attendees as well as the interpreted languages offered. This will be maintained by ELARC for ongoing review.

#### **Set Meeting Schedule**

A document that outlined meeting dates and topics for 2016 was reviewed and approved by the committee. The approved dates and topics are outlined below. It was advised that it is important to note that these topics might be changed as the year progresses depending what questions may be raised, the topics attendees express a desire to learn more about, and the progress of the waiver application.
