 - Stakeholder Group
 - CMS reviews and approves

How to move money

Source: The Law

• WIC 4685.8 (n){3} The individual budget shall be assigned to uniform budget categories developed by the department in consultation with stakeholders and distributed according to the timing of the anticipated expenditures in the IPP and in a manner that ensures that the participant has the financial resources to implement his or her IPP throughout the year.

How to move money: The Law

• WIC 4685.8(o) Annually, participants may transfer up to 10 percent of the funds originally distributed to any budget category set forth in paragraph (3) of subdivision (n) to another budget category or categories. Transfers in excess of 10 percent of the original amount allocated to any budget category may be made upon the approval of the regional center or the participant's IPP team.



Quick Quiz

Service	Budget Amount
Housing Access Supports	5,000.00
Dental Services	2,000.00
Transportation	3,000.00
TOTAL	10,000.00

Yvonne wants to move \$100 from her transportation budget amount to her dental services. Does she need approval?



No. \$100 is less than 10% of \$3,000.00. It would need to be over \$300.00 to require approval.

Changes to the Budget

- Source: The Law
- WIC 4865.8 (n)(iii) (2) The amount of the individual budget shall be available to the participant each year for the purchase of program services and supports. An individual budget shall be calculated no more than once in a 12-month period, unless revised to reflect a change in circumstances, needs, or resources of the participant using the process specified in clause (ii) of subparagraph (A) of paragraph (1). (original determination methodology)
