# Consumer Advocate Report – Jesse Padilla

- ➤ At the recent Access Services meeting, the following announcements were made:
  - Access is still having issues with the bus stop stand signs at large facilities and is currently working to rectify the problem.
  - o They signed a new contract for customer service which their Board approved. The name of the company is ALTA Services.
- ➤ Jesse announced that there will be a Supported Life Conference presented by the Supported Life Institute and the SCDD Sacramento Office on October 6<sup>th</sup> and 7<sup>th</sup>. The training will cover various topics such as relationships, personal power & rights, family supports, and other interesting areas. Save the date flyers will be distributed.

- ➤ A class action lawsuit against the City of Los Angeles to improve access for persons with mobility disabilities to the city's sidewalks, curb ramps, and other walkways, has been resolved. The settlement calls for a \$1.4 billion investment to repair city's sidewalks and other walkways over the next 30 years. A handout will be given upon request.
