Access Services

 At the recent Access Services meeting, Jesse joined the Mobility Subcommittee, which is a group that will help find ways on how to improve and encourage more riders to use Mobility Training.

ARCA CAC

• Jesse attended the ARCA CAC and announced the latest update on the budget. There is a new Managed Care Tax organization that will bring more money into the system which will help improve it.

Statewide Self Advocacy Conference

- Jesse attended the Statewide Self Advocacy Conference. There were two sessions and the following topics were discussed:
 - Assertiveness: How to become more assertive, not aggressive. This
 workshop explained the difference between the following: Body language,
 assertiveness, demanding, and anger.
 - Education: A panel of individuals with disabilities shared their story on how they reached their education goals. There were four individuals who have graduated from college.

Systems Update – Gloria Wong, Executive Director

- ➤ The budget situation is much better this year. We will be finishing off the fiscal year on June 30th and a new one begins July 1st. Things have improved dramatically for us this past year. The governor has approved funding for our system which will allow us to hire more service coordinators and adding an Employment Specialist position for every regional center.
- ➤ This year the Lanterman Act celebrates its 50th anniversary of supporting people with developmental disabilities in the community. This very significant law has given rights to people with developmental disabilities to receive the services and supports they need in the state of California. In order to honor the Lanterman Act, each of the 21 regional centers will be compiling their own video that describes what the Lanterman Act means to them. Individuals we serve, families, service providers, and staff is encouraged to participate and include their thoughts and comments.

Education and Employment Presentation

- Luana Acuña, Executive Director from In2vision Supported Employment Programs gave a beneficial presentation on the supported employment programs and options. She explained how SEP agencies can help find individuals find jobs, filling out job applications, and preparing for interviews, and other job readiness skills.
- Mark Matsui, DSPS Director of Rio Hondo College presented on the wide array of college services Rio Hondo College has to offer for individuals with disabilities.
