Welcome and Introductions

The meeting was called to order at 6:00 pm by Virgilio Orlina, Chair. A quorum was present to conduct business. Gloria Wong greeted the attendees. Virgilio introduced Victor Lira and Christine Sheppard to present on "The Role of the Fiscal Management Service (FMS)"

Presentation: "The Role of the FMS"

- Christine and Victor provided an overview of FMS services, an update on the SD waiver as it related to the FMS, and spoke of their experiences working as an FMS agency in the current Self Determination pilot.

Updates

- Statewide Self Determination Project Update
 - o Virgilio provided an update on the Statewide-Self Determination Advisory Committee.
 - The committee met on October 26. The Department of Developmental Services (DDS) reported on the status of the Centers for Medicaid/MediCal (CMS) review of the waiver application and the training modules. There was a survey sent out regarding outreach and there was discussion regarding how pre-enrollment will work and the role of the Advisory Committees in preenrollment.
 - o Gloria provided the update on the status of the implementation of the program statewide.
 - It has been nearly three years since the law passed. DDS has continued with their dialogue with CMS on the 181 questions related to final approval of the waiver application. DDS is working with CMS on technical assistance to answer some 30 remaining questions and finalize the application. They had initially shared that there would be a July release for public review and subsequent August submittal of the application for approval, however as of this date there has not been any public posting. The issue of the payment of the FMS may need to go back to the legislature should it be deemed that payment shall not come out of the budget as part of the waiver approval.

• The modules for training the Regional Centers are considered final and should be implemented early in 2017.

Outreach and Information Planning

- Liz just presented to the ELARC Consumer Advisory Committee on Self Determination prior to this meeting (at 4 pm on 11/1)
- Liz partnered with Chris Arroyo from SCDD to present an overview of Self Determination in both English and Spanish at the Fiesta Educativa conference on September 30
- Liz Harrell, Liz Rodgers (ELARC Autism Specialist) and Chris Arroyo from the State Council presented a training on the Person Centered Approach to the IPP and how it relates to Self Determination at ELARC on October 13.
- New collaborative agreements are in place for 2017 with the Chinese Parents Association, Fiesta Educativa, and the Greater Long Beach/San Gabriel Valley Autism Society Chapter.
