Welcome and Introductions

The meeting was called to order at 6:00 pm by Virgilio Orlina, Chair. A quorum was not present. Virgilio greeted attendees and introduced David as the facilitator as Liz Harrell was out of town. David facilitated the panel presentation of Eddie Bueno, Accredited and Theresa Chen, Parent of a Pilot Participant on "What ELARC has learned from piloting Self Determination."

Presentation: "What ELARC has learned from piloting Self Determination"

- There was the opportunity for the guests ask questions and obtain clarification throughout the presentation. Questions tended to focus on the new program, questions included:
 - The types of services and supports that can be purchased
 - o How the budget is determined
 - The decision making process in Self Determination
 - Working with a fiscal management organization
 - o How will quality assurance work

Approval of the Agenda and Minutes

Community Input

Updates

- Statewide Self Determination Project Update &
 - Virgilio provided an update on the Statewide-Self Determination Advisory Committee, which has been gathering information on how the local committees operate and share information. They will be meeting again soon.
 - David provided the update on the status of the implementation of the program statewide.
 - The new Self Determination program can start once California obtains approval from the Federal government. That approval process is achieved through California submitting an application for a "medicaid waiver." The application was originally submitted about two years ago.
 - The application had been returned to the California Department of Developmental Services (DDS)
 from the Federal Centers for Medicare and Medicaid Services (CMS) with 181 questions, now down
 to about 2 -3 questions primarily around service descriptions (ie- what's the difference between
 respite and day care?)

- Anticipated that DDS will finish up the descriptions, finalize the full response, and have the
 application ready to go within a month. They have spent this time working with CMS to rework the
 application. The application does have to be reviewed by the California Department of Health
 Services prior to sending to CMS.
- Once the application is with CMS again, the "90 day Clock" starts-meaning CMS has to respond
 within 90 days to the application. There is no requirement to post the application for 30 days prior
 to sending it to CMS, so, if the application is approved on schedule, SD could roll out within 4 to 5
 months
- We will keep you posted. When the application is sent to CMS, we will post the date on our website.
- We are gearing up to roll out training and outreach in light of this news. DDS will distribute a Training Webinar to the regional centers in approximately a month. The required pre-enrollment trainings at the regional centers will commence after the approval of the waiver as part of the implementation process.
